I AGREE in consideration for my participation in this Competition to the following:

I AGREE that the Sweet Summertime Horse Show and Old Seoul Equestrian LLC and "Competition" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.

I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, vaulter, longeur, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("harm")

I AGREE to hold harmless and release the Old Seoul Equestrian LLC/Sweet Summertime Horse Show and the Competition from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm of any nature caused by me or my horse to others, even if the Harm arises or results, directly or indirectly, from the negligence of the Old Seoul Equestrian LLC/Sweet Summertime Horse Show or the Competition.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Old Seoul Equestrian LLC/Sweet Summertime Horse Show or the Competition.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Old Seoul Equestrian LLC/Sweet Summertime Horse Show and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse while at the Competition.

I have read the Competition Rules about protective equipment, as stated in the Prize List and I understand that I am entitled to wear protective equipment without penalty, and I acknowledge that Old Seoul Equestrian LLC/Sweet Summertime Horse Show strongly encourages me to do so while WARNING that no protective equipment can guard against all injuries.
